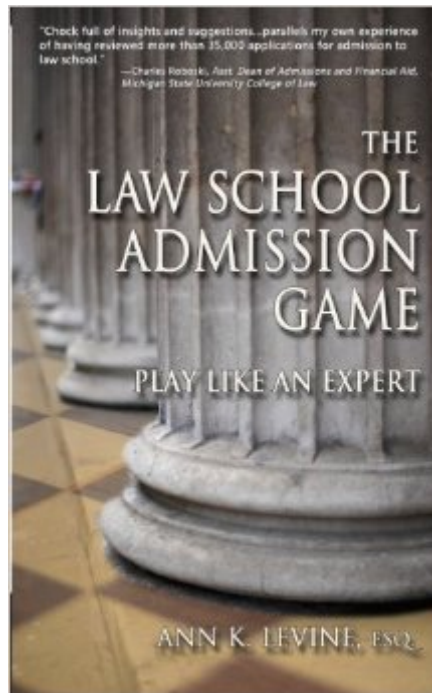

I teach LSAT in San Francisco, and my classes are heavily question-driven. (Students can ask whatever they want, and I do my best to answer.) I've always gotten a ton of questions that range away from the LSAT and toward the broader law school application process. So I realized early on that my job wasn't just LSAT preparation. It's also to help people make good decisions about where to apply, when to apply, what to include in the application, and what offers to accept. To that end, I just added The Law School Admission Game to my course curriculum. I blew through it over the past two days--it's a great read--and I decided immediately to give it to all my students from this point forward. It fills a huge hole in what's offered by most LSAT prep programs, and I'm proud to offer it as part of my classes. Below, I'll give my thoughts (overwhelmingly positive, with a few quibbles) about the book. But if you're applying to law school you really should just buy yourself a copy. I promise you'll be very happy you did. Levine is a law school admission consultant and owner of the LawSchoolExpert website. Why is she the law school expert? Well, she was Director of Student Services at the University of Denver College of Law, Director of Admissions for California Western School of Law, and Director of Admissions for Loyola Law School. That's a good start. She's also a lawyer, of course (University of Miami School of Law). But despite all that, I didn't believe she was an expert until I started reading. Inside the first 10 pages, I was a believer. It's written like an expert would write. No bull, no filler. This isn't a 500-page encyclopedia that you're never going to read.
